#### **Tender Notice**

The offers may be submitted in TWO-BID SYSTEM (A-Technical Bid and Financial Bid), by the reputed and experienced agencies / firms /companies.

The tenderer will have to deposit earnest money of Rs. 20,000/- (Rupees Twenty Thousand Only) in the form of CDR/TDR drawn in favour of "General Manager, J&K Grameen Bank" along with the technical bid.

#### TERMS AND CONDITIONS OF THE TENDER & GENERAL INFORMATION

Please read carefully before filling up the Tender Document. Incomplete Tenders will be rejected.

#### 1. Scope of the work :

a. Publication of Sarfaesi, Tender, Event Publicity and Bank etc. related advertisements on local / national level

b. Giving assistance in preparation of media plan, providing details of various publications across given geographical area as per rates finalised.

c. Exchange of requirement and information shall be done through email communication. Only in exceptional situation, contracting agency official may be invited at the Bank.

d. Publication of advertisement as approved by the Bank in the given news papers as per the quotation approved.

2. The award of work is for an aggregate period of 3 years, which will initially be given for a period of one year and reviewed for extension for another year(s) subject to satisfactory performance at the discretion of competent authority of J&K Grameen Bank on the same terms and conditions.

3. The contracting agency/firm/company shall provide services continuously as per the award of contract.

4. The contracting agency/firm/company shall not be allowed to transfer, assign, pledge or sub-contract its responsibilities, rights and liabilities under this contract to any other agency/ firm/ company without prior written consent of the Bank.

5. The contracting agency/firm/company shall abide by the rules and regulations of State / Central Government authorities particularly applicable to the business and shall have requisite licenses, sanctions, registration, accreditation which should be valid during the tenure of contract.

6. J&K Grameen Bank reserves the right to terminate the contact at any time without assigning any reason by giving one month notice to the contracting agency/firm/company.

7. In case required services are not provided by the contracting agency on time, j&K Grameen Bank will be free to get the work done from any other agency from open market and the expenses on this account will be debited to the contracting agency which will be recovered from the dues / pending bills, performance security deposit etc.

8. The successful agency / firm / company shall assign a designated official who shall be responsible for immediate interaction with Banks designated official so that optimal services could be availed without any disruption. The designated official of the agency / firm / company should be available round the clock on his own direct telephone (office as well as residence & mobile) so as to respond to the call for services in emergent cases. The supervisor should be accessible on Holidays / Sundays also for satisfying BANKs requirements.

9. The contracting agency shall submit its bill along with the copies of the bills of the respective publication and original page of the publication on which the advertisement was appeared within 30 days to the Banks official through whom the advertisement was given. On total bill of publications, contracting agency will offer the discount as offered in the Financial Bid.

10. Payment against Bill shall be made only after satisfactory services to be certified by the

concerned Banks official. No interest will be payable on the nonpayment due to delayed submission of bills and non-satisfactory services. No advance payment will be made. The payment will be made only by transfer within 15 days from the date of receipt of bill.

11. The agency / firm / company shall be liable for depositing all taxes, levies, cess, etc. on account of services rendered by it to JKGB to concerned tax collection authorities from time to time as per extant rules and regulations on the matter.

12. The Income Tax (T.D.S.) shall be deducted at prevailing rate from the monthly bills in accordance with the provisions of Income Tax Department and a certificate to this effect shall be issued by the Bank to the contracting agency.

13. In case, the agency / firm / company fails to comply with any statutory / taxation liability under appropriate law, and as a result thereof J&K Grameen Bank is put to any loss / obligation, monitory or otherwise, JKGB shall be entitled to get itself reimbursed out of the outstanding bills /performance security deposit to the extent of the loss or obligation in monitory terms.

14. The successful tenderer will have to execute an agreement with JKGB broadly covering scope of work, requirements, terms and conditions of the services to be provided to the Bank on a non judicial stamp paper of appropriate value, the cost of which will be borne by the successful agency/firm/company.

16. The General manager, JKGB reserves the right to award contract for required services either to one party or more than one party. He also reserves the right to amend or withdraw any of the terms and conditions mentioned in the tender document or to reject any or all the tenders without giving any notice or assigning any reason and not bound to accept the lowest tender. The decision of the Bank in this regard shall be final and binding on all.

17. Agencies who are member of INS (Indian Newspaper society) and are accredited to AAAI(Advertising Agencies Association of India)shall be preferred in case the rates submitted by the agencies are same. Agencies need to submit Copy of INS & AAAI accreditation, wherever applicable. Bank reserves the right to verify the same.
